Planning Applications to be considered

- (a) 19/03221/TCA-To fell three fir trees with in Baschurch Centre Conservation Area at Moor Farm House, Nobold, Baschurch, Shrewsbury. Shropshire

Cllr J H Lloyd had previously proposed to support the application. This had been seconded by Cllr J Carr and agreed by all present. Shropshire Council had been informed.

19/03270/OUT- Outline application for the erection of a detached bungalow (all matters reserved) at Willows, Station Road, Baschurch, Shrewsbury, Shropshire.

- 7.40pm Standing Orders were suspended. The applicant and his mother made representations to the Parish Council as to why they wished to build the dwelling.

- 7.50pm Standing Orders were re-instated.

Councillor J H Lloyd outlined the application to the Parish Council and a discussion took place. Cllr Mrs S Richards proposed to support the application in principal. It was felt it was an exceptional site but concerns were raised that the application was slightly outside the village boundary and if granted this should not be an established precedence. This was seconded by Cllr P Ridgley and passed with one abstention. Shropshire Council to be informed.
